Discussed City Projects.

Julie Rastetter and Sherry Oliver with Umbrella Arts presented information for pillar art. Sculptor Tim Adams has been secured by the group for the project. Proposed addition would be a 14-foot-high and 5-foot-wide structures on the Schiller sides of pillars constructed of steel, plexiglass and contain led lighting. Umbrella Arts also would like to replace sign on west side of pillars, same materials as other pillars, art work, led lighting and same artist would design. Umbrella Arts will work on grants and other funding but this would need to be a City project. Parker made a motion to approve City getting electrical to pillars and Umbrella Arts moving forward with project. Greve seconded. Vote: Ayes: Parker, Greve, Ludovissy, Bahls and Geuder. Nays:0. Discussed nuisance issues. Send additional letter regarding unsafe crossings (China Street and Herder Street), post phone number on FB, Channel 6, other areas (website).

Discussed health and vision insurance renewal. Parker made a motion to approve the renewal. Ludovissy seconded. Vote: Ayes: Parker, Greve, Ludovissy, Bahls and Geuder. Nays:0. Motion Carried.

Discussed Chamber/CV Requests. Discussed dog park hydrant contest. Decommissioned hydrants from the water improvement project will be used, \$100 prize for the winner. Bahls made a motion to approve contest. Greve seconded. Vote: Ayes: Parker, Greve, Ludovissy, Bahls and Geuder. Nays:0. Motion

Carried. CV/Chamber job description approved in 2022 was presented to the council. Patty Schwarz with the Chamber of Commerce spoke regarding the Stars & Stripes 5K and kids fun run. Organizers are gathering information from hospital regarding the GermanFest 5K. Kids Fun Run will be ¼ mile free run. There will be a fee for the 5k run. No road closures needed, asking Clayton County side by side club for assistance for safety of the runners. Bahls made a motion to approve Stars & Stripes 5K and kids fun run. Greve seconded. Vote: Ayes: Parker, Greve, Bahls, Geuder and Ludovissy. Nays: 0. Motion Carried.

Greve made a motion to approve the final reading and passage of Ordinance No. 711-24, An Ordinance Amending the Code of Ordinances of the City of Guttenberg, Iowa, By Amending Provisions Pertaining to Water Rates & Sewer Rates. Parker seconded. Roll Call Vote: Ayes: Parker, Greve, Geuder, Ludovissy and Bahls. Nays:0. Motion Carried.

Discussed work from home policy. Bahls made a motion to table to allow more time to review the policy. Parker seconded. Vote: Ayes: Bahls, Parker, Greve, Ludovissy and Geuder. Nays:0. Motion Carried.

Discussed Public Works Director's request for temporary summer hours. Blume reminded council that the water line surveys required by the DNR need to be completed by October and that extended hours might allow for additional time to schedule surveys. Bahls offered to survey houses for water inspections if help is needed for nights and weekend. Parker made a motion to approve temporary summer hours for a 2-month trial period. Ludovissy seconded. Vote: Ayes: Bahls, Parker, Greve, Ludovissy and Geuder. Nays:0. Motion Carried.

Discussed Juanita Loven's request for park improvements. Bahls made a motion to approve the project. Greve seconded. Vote: Ayes: Parker, Geuder, Greve, Ludovissy and Bahls. Nays: 0. Motion Carried.

Kari Smith and Paul Decker with GMHC presented information on the request for a new ambulance. Discussed first quarter of 2024- 44 transfers were made. Discussed that they will be wanting to replace the other one in the future. The current agreement is outdated, there is a need for a joint meeting between Council and Hospital Board to update the agreement. Ludovissy made a motion to approve ordering new ambulance for \$126,276, final quote with using some equipment from old ambulance. Parker seconded. Vote: Ayes: Parker, Geuder, Ludovissy, Bahls and Greve. Nays:0. Motion Carried.

Bahls made a motion to approve Justin Wilson as Volunteer Firefighter pending Department approval. Geuder seconded. Vote: Parker, Geuder, Ludovissy, Bahls and Greve. Nays:0. Motion Carried.

Parker made a motion to approve quotes for electric updates for FY 25. Greve seconded. Vote: Ayes: Parker, Geuder, Ludovissy, Bahls and Greve. Nays:0. Motion Carried.

Bahls made a motion to approve the low bidders for the street improvement projects for FY 25. Parker seconded. Vote: Ayes: Parker, Geuder, Ludovissy, Bahls and Greve. Nays:0. Motion Carried.

Discussed Dan Pierce's additional employment request to continue coaching through Clayton Ridge Community School District. Parker made a motion to approve request. Bahls seconded. Vote: Ayes: Parker, Geuder, Ludovissy, Bahls and Greve. Nays:0. Motion Carried.

Patty Schwarz requested to address council regarding the Chamber. Patty feels the Chamber does not receive the recognition for all that they do in the city. Feels as though Chamber agenda topics frequently get tabled for future meetings. The Chamber would like to see more appreciation and friendliness at future meetings. Jane Parker responded to rumors following the Personnel committee meeting on 05/06/2024. She shared the following, "If you'd allow me, I'd like to read my response so that my words aren't mis-quoted later. When any person is hired by the City, which is the tax payers, the employee is held to a standard of accountability, professionalism and customer service. A few times in the past the Chamber Director was an employee of the City but for whatever reason those positions vacated and the City, it's tax payers, returned to budgeting a stipend to the Chamber and the Chamber Board paid the Director and had direct responsibility of the Chamber functions and it's Director. My suggestion was that the City return to that model of support for the Chamber. In other words, The City, it's tax payers, would budget a much larger stipend than was given in years past to the Chamber, the Director would no longer

be an employee of the City but rather of the Chamber Board. This would give the Chamber Director less accountability to the City Mayor, Council and City Manager and more direct supervision from the Chamber Board."
